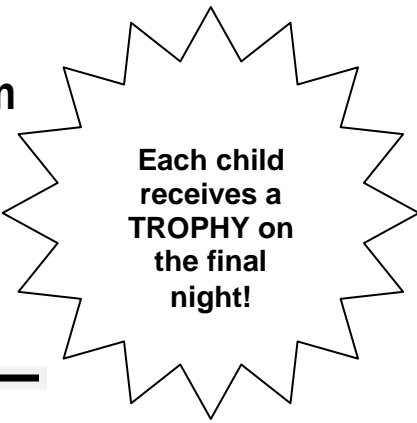




Kids Run for Fun - 2010 Registration
